Congregational Trauma, Resilience, and Healing

Groups as well as individuals can suffer the adverse effects of trauma. This advanced sexual ethics workshop equips participants to recognize congregational trauma and to implement practices to increase resilience and healing within a congregation. PREWORK (nos. 1–6 below)

Physiology and psychology of trauma

1) Watch the 5-minute video from KPJR Films, creators of the documentaries, "Paper Tigers" and "Resilience." This video provides a primer on a specific set of traumatic experiences called "Adverse Childhood Experiences (ACEs)": https://vimeo.com/139998006.

Qs: What are Adverse Childhood Experiences (ACEs)? What do they have to do with lifelong health?

2) Watch the 5-minute video by Dr. Jacob Ham, clinical psychologist, researcher, and Director of the Center for Child Trauma & Resilience at the Icahn School of Medicine at Mount Sinai in New York. Qs: What is the difference between "learning brain" and "survival brain"? What does trauma do to one's ability to learn?

3) Watch Mineola Grows!, "The Hand-Brain Model! | Self-Regulation Lesson 2," https://www.youtube.com/watch?v=lRmnVmELMn8. Did you know that we can use our hand to model the regions of our brain?

Qs: Represent your brain with the hand model described. Then, "flip your lid." What does this represent about the ability to make good decisions when overwhelmed by emotion?
